NOTES ABOUT TAKE HOMES:

- You can download the exam questions at any time during the stated availability period.
- Once you download an 8, 48 or 74 hour exam, you must complete it and upload it within the stated number of hours, or by the end of the availability period, whichever comes first.
 - FOR EXAMPLE – If you download the Antitrust exam questions at 1 p.m. on May 6, you must upload your answers by 6 p.m. on May 8 (even though the full 74 hours allowed for the exam has not passed).
- In order to have the full time for an 8, 48 or 74 hour exam, you must download it at least 8, 48 or 74 hours (the stated # of hours for the exam) prior to the end of the availability period. If you do not do so, you will be giving up part of the time you have to complete the exam.
- For all take home exams, any exams uploaded after the availability period ends will be deemed late.
- Students in Professional Responsibility ITP with Prof. Myers will be notified by email about arrangements for this exam, and should expect to take it on the dates discussed in the course syllabus.
