## NOTES ABOUT TAKE HOMES:

1. You can download the exam questions at any time during the stated availability period.
2. Once you download an 24, 48 or 74 hour exam, you must complete it and upload it within the stated number of hours, or by the end of the availability period, whichever comes first.

**EXAM CONFLICT FORMS DUE NOVEMBER 9, 2020**

- a. FOR EXAMPLE – If you download the Mergers & Acquisition exam questions at 1 p.m. on Dec. 21, you must upload your answers by 6 p.m. on Dec. 21 (even though the full 74 hours allowed for the exam has not passed).
3. In order to have the full time for a 48 or 74 hour exam, you must download it at least 48 or 74 hours (the stated # of hours for the exam) prior to the end of the availability period. If you do not do so, you will be giving up part of the time you have to complete the exam.
4. For all take home exams, any exams uploaded after the availability period ends will be deemed late.
